

Clay Ingels Ugly Door Contest

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. The Clay Ingels Ugly Door Contest (the "Promotion") begins at or about 10:00 AM ET on July 8, 2016 and ends at 11:59 PM ET on July 17, 2016 ("Promotion Period"). The Promotion is open to legal residents of the fifty (50) United States (and the District of Columbia) who are at least eighteen (18) years old at the time of the Promotion start date.

Employees, agents, immediate family members, and household members of JMIS Kentucky, LLC (the "Administrator"), Clay Ingels Co., LLC, (the "Sponsor"), the University of Kentucky, and their respective parent, subsidiary, successors, assignees, and affiliated companies, and their respective advertising and promotion agencies (collectively, the "Promotion Entities") are not eligible for the promotion. "Immediate family members" shall mean parents, step parents, children, step children, siblings or spouses, and "household members" shall mean people who share the same residence at least three (3) months per year.

HOW TO ENTER: During the Promotion Period participants may enter the promotion using the following method:

1. Facebook: Visit the UK Sports Network's Facebook page and post a picture of their front door in the comments section below the contest post to receive one (1) entry.

All entries must be submitted no later than 11:59 PM ET on July 17, 2016 to be eligible.

Limit of one (1) entry per person throughout the Promotion Period. Entries will be declared made by the authorized account holder of the Facebook account submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to the Facebook account by Facebook. Entries generated by script, macro or other automated means (including sweepstakes entry services) are void.

VOTING PROCESS: One (1) winner according to the highest Facebook "like" count at the time of promotion end will be selected from all eligible entries received by the deadline at or about 5:00 PM ET on July 18, 2016, verified by the Administrator. Odds of winning depend on the number of eligible entries received and number of Facebook "likes" received.

WINNER NOTIFICATION: The potential winner will be notified by Administrator via phone and/or email and will be required to respond within twenty-four (24) hours of notification. The potential winner shall also be required to sign and return an affidavit of eligibility, a release of liability and a publicity release (where permitted by law). The prize will be forfeited and, at Administrator's discretion, an alternate winner may be selected if: (i) such documents are not returned within the specified time period; (ii) prize notification is returned as undeliverable; (iii) Administrator is unable to contact a potential winner within the time period specified; or (iv) a potential winner is not in compliance with these Official Rules.

The winner may not substitute or redeem any prize, or any portion of any prize, for cash, but Administrator reserves the right, at its sole discretion, to substitute any prize (or portion thereof) with one of comparable or greater value. The winner is responsible for all applicable federal, state and local taxes, if any, as well as any other costs and expenses associated with prize acceptance and use not specified herein as being provided; including, without limitation, travel related to the Prize and additional accommodations for the Clinic on July 23, 2016. All Prize details are at Administrator's sole discretion. Prizes are awarded "as is" with no warranty or guarantee, either express or implied by Administrator.
